From the Advocacy File

The Rideau Waterway Land Trust started an advocacy program in 2015. Advocacy for the RWLT simply means working with the various levels of government to encourage legislation or programs that would enable the organization to better do its work in preserving natural lands in our community. It must be remembered that the RWLT is a registered charity and as such is restricted by legislation to spending no more than 10% of its annual revenues on this activity.

As with any program the wish list is often longer then the resources available but it was decided that a priority list of three items would be decided upon. The initial list included:

- 1. A request to the Township of Rideau Lakes to allow for free dumping of brush gathered from the community trails and delivered to the municipal brush depot by volunteers. To date it should be noted that the Township of Rideau Lakes charged tipping fees to accept brush from the community trails located in the township.
- 2. The RWLT is monitoring and has made representation to the County of Leeds and Grenville encouraging a policy within their new Official Plan to encourage municipalities to waive the planning fees and parkland fund allocation for lands designated under their natural heritage systems that will be donated to land trusts.
- 3. Finally the third priority was to the Province of Ontario to deal with applications to the Conservation Land Tax Incentive Program (CLTIP) in a more timely fashion. Currently some RWLT applications have been languishing on government desks' for 4 years waiting for the Province to issue a recommendation as to whether certain natural lands should be exempt from property tax, which is causing financial hardship for many land trusts as they struggle to pay the property tax on their lands while expecting no services in return.

The committee is pleased to report that the Township of Rideau Lakes has agreed to accept up to 300 kg of brush from RWLT lands in their municipality for the 2015 year. Future years will have to be discussed. The other two items have still not been settled.

The first item was replaced with another issue that involves the Township of Rideau Lakes. The Committee of Adjustment for the township recently approved a minor variance for construction of a dwelling on a waterfront lot

of less than a ¼ acre and in fact the entire dwelling is within the required 30 meter set back from the water as the lot is only 21 meters deep. I am sure you will all agree that our lakes have to be protected and the ways of the past are not acceptable in the current environment. This decision will be appealed to the OMB by the Big Rideau Lake Association supported by the RWLT. This decision cannot be allowed to stand as it will open the gates for further applications for minor variances and will mean all undersized lots and all islands, no matter the size can be built on.

The Land Acquisition Program

The Land Acquisition program always seems to be busy. We are mostly successful in completing projects, as evidenced in 2014 with the completion of the acquisition of the Edwards property on Big Rideau Lake and the Covington property on Bull's Eye Lake. The Edward's property acquisition was rather complicated and was first proposed in 2004 while the Covington property was transferred much quicker as it was offered to the RWLT in September of 2014. The Trust recently ran into legal complications on one potential donation that it is unable to resolve but is currently working on two others that are still on schedule. In fact as of the writing of this newsletter the RWLT is submitting an offer to purchase on some natural lands along the Rideau Waterway with the financial support of one of its staunches supporters.

The committee wants to remind all supporters that land acquisition is very expensive and even if the land is donated there are still many costs, both acquisition costs and future land management costs that must be considered. The RWLT is always happy to talk with supporters who wish to make a special financial contribution to ensure all lands offered can be secured for future generations.

Equipment Needs

The RWLT has 7 properties that are only accessible by water and it had no boat. A long-time supporter has stepped forward and donated an aluminum boat and motor to the Trust. However, by his own admission, the trailer is questionable. The Trust needs another supporter(s) to help us fund a trailer. A brand new roadworthy trailer is \$1,260 including all taxes. Can you or someone you know help us with this need? Once we receive the trailer the volunteers will be on the lakes and rivers to monitor our properties and help with the acquisition of further properties. 
