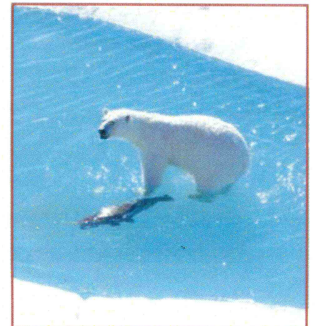

## RWLT Annual Campaign

Every year at this time we ask our supporters to make a special gift to the Land Trust. This gift ensures that the RWLT remains a vibrant and energized organization. In September, your Land Trust became the first in Canada to complete an organizational assessment using the new Canadian Land Trust Standards and Practices. The results were encouraging as the RWLT continues to be recognized as one of the leading community based land trusts in Canada. However, to remain at the forefront it is essential that the board, volunteers, and staff continue their ongoing education programs.

This year's Annual Campaign donations will allow the RWLT to continue its program of education and training for board members, volunteers, and staff, as we strive to implement all 94 practices contained in the Canadian Land Trust Standard and Practices.

These Standards and Practices apply to our Land Acquisition and Land Management Programs. Better practices for property acquisitions and conservation easements are covered under these rigorous guidelines. Training for our board and staff is critical to ensure we keep up to date with the latest regulations required for the different acquisition tools we use. The Land Trust now owns and manages over 555 acres of land and protects 15,000 feet of shoreline along the Rideau Corridor for the benefit of the community. The Board agrees with the results of our recent survey. Respondents emphasized the importance of managing these lands well. Your special gift will contribute to our volunteer land management training programs.

All RWLT board members and staff are also trained in the legal and ethical practices of philanthropy and fundraising activities. The RWLT remains accountable to you, our donors.

Our volunteers and staff are always learning. In fact they are frequently asked to serve as teachers for other smaller organizations at regional and provincial workshops. We share our expertise in land acquisition, organizational development and fundraising with new land trusts starting up, as well as other non-profit organizations within your community.

We owe our gratitude to you. Our successes are a direct result of your support. Every year when you give to the Annual Campaign, you make your Land Trust stronger. Volunteers and staff work more efficiently and effectively when well trained as the RWLT strives to reach even higher goals in 2007.

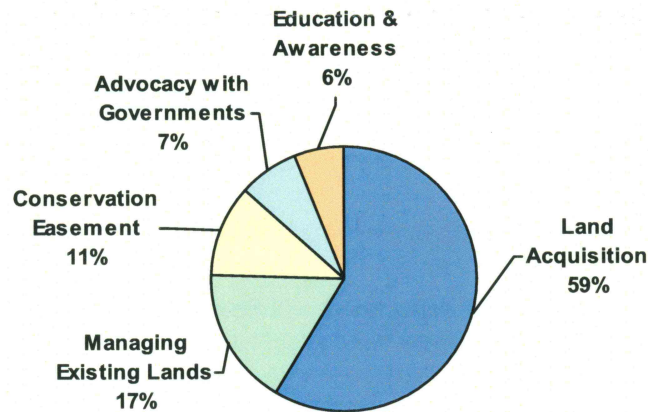

# New Strategic Plan for RWLT

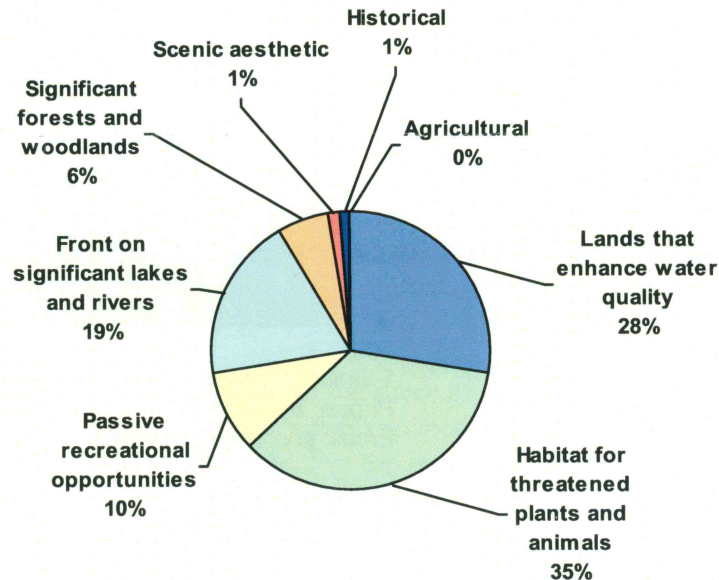
The Board of Directors and staff of the RWLT have recently begun an intensive new strategic planning program. The Land Trust has initiated numerous acquisitions and programs in the past few years and the Board felt it was time to look ahead to the future and our long range planning. The process is expected to take several months to complete. We thank the Ontario Trillium Foundation for providing funding for this project which allowed the Land Trust to engage a professional facilitator to aid in this program.

In late October we sent a questionnaire out to over 300 members and supporters randomly chosen from our database. We wanted input regarding the priorities you felt were most important. The first question asked was an important one. Participants were asked to rank their priority for RWLT programs.

## Programs ranked most important by respondents:



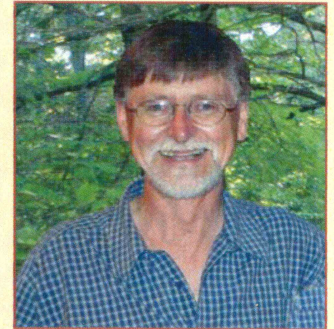
## Types of land ranked most important for preservation by the Land Trust:





## MEET YOUR BOARD - Director Simon Lunn

Simon Lunn is serving his second term as a Board Member, where, in his words, he feels “privileged to work with members of an organization dedicated to protecting special natural places in our local community”. Simon’s passion for the outdoors and nature began at an early age in rural Ontario. If it wasn’t his parents taking a young family off exploring somewhere on a weekend fieldtrip, it was being the youngest member of the Richmond Hill Naturalists Club or the adventures of being a Boy Scout that offered Simon a venue for his developing naturalists skills. Of course his fate was really sealed 37 years ago when he met another budding biologist, his school sweetheart (and future wife) Carolyn, where they both received M.Sc. degrees at Acadia University in Nova Scotia’s Annapolis Valley.



Since the early 1970’s, Simons’ career as a naturalist, interpreter and biologist (among his various pursuits) took him from the maritime provinces, to Alberta, and back to Ontario, where he worked for organizations like the Canadian Wildlife Service, Ministry of Natural Resources and Parks Canada. He and Carolyn feel blessed to have lived in national parks and sites across the country. Before his retirement in 2004, Simon worked as an Ecosystem Scientist for Parks Canada at the Rideau Canal. Simon and Carolyn live near Smiths Falls, and enjoy sharing time with another budding biologist, their daughter Heather who lives in nearby Perth.
